

**Montvale Environmental Commission Meeting Minutes**

Environmental Learning Center walkways cleaned on April 28 by Boy Scouts and Leaders – well done. Walkway needs power washing. Thank You to the Montvale Boy Scouts and Leaders!  
Interconnect between Wegman & Learning Center just needs signage for directions  
“House” for trail notes to be suggested as Scout project for Learning Center  
Tree ordinance: Congratulations!!! After 19 years of re-writes. An ordinance is accepted which will have minimal impact on the general public yet help reduce the disregard of trespass during construction events.  
Homework for EC...read and become very familiar with the ordinance.  
Gus DeBlasio from Maser will be present when any reviews are necessary.  
Inter-municipal trail – met with NJ Trail Conference. They felt it would be low cost to create trail. Any wetland area can be outfitted with a “floating wood bridge”. During walk through on 4/4/18 discussed trail behind new Fire House with Fire Chief who felt it would be a good thing for the community. Very natural trail already exists. \$2500 is needed for NYNJTC to create plans. Additional \$10K-15K needed for screening, material, etc. M. Kelly will take on that responsibility to encourage local business to donate.  
M & C meeting to discuss center of town plans. EC has update plans with future planting suggestions. Chairman Hanrahan, M. Jensen to attend 5/29 meeting at 7:30- PM  
Huff Pond now has a working aerator. Noted floating item was also removed by DPW.  
Wetland ordinance will be reintroduced to the M&C to help raise awareness and protect Wetlands. Chairman Hanrahan will take action.

### **Old Business**

Montvale Clean Up Day: Of the 14 towns and Groups who participated Montvale had more attend than all others....attendance reached 143 +  
Over 2 tons of trash collected. Notes for next year...need more t-shirts.

Montvale Swim Club Property: April 9 Subcommittee Meeting attended by R Hanrahan, Dan Eichhorn, M. Jensen, M. Kelly from EC—EC suggestions focused on trail concept. Most attending agreed that the trail was a good idea. Sub-Committee Chairman Weaver suggested consideration of investment in a new Community Center; possibly remove existing Community Center to accommodate a much larger structure. Chairman Weaver to ask the M&C for guidance on next steps.
