### New Business:

- Ginny Millard presents to the EC on the documentary “Drift”
  - Highlights an effort to save Barnegat Bay and ensure the Barnegat Water Shed (spans from Brick to Cape May) is preserved.
  - Purpose is to educate people about different environmental issues and inform visitors to the area on how to take better care of the environment.
  - Flooding is taking longer to dissipate and it is causing problems in the Barnegat Bay area.
  - The Montvale Library has agreed to show the documentary which was produced by Monmouth University on May 5<sup>th</sup> at 7 p.m.
- Bergen County Clean Communities Grant Approval
  - A mini-grant for 2022 was approved.
  - As long as we sponsor a yearly clean-up day we will qualify for the grant funding.

- Clean Up Day – Saturday, April 23<sup>rd</sup> from 9:00 a.m. to 12:00 p.m.
  - Please let Bob or Ellen know of any locations in need of clean up attention.
  - We will add the Octagon House and Field House #2 to our list of clean-up sites.
- Arbor Day on April 22<sup>nd</sup> and Earth Day on April 30<sup>th</sup>
  - We purchased 200 trees from the Arbor Day Foundation to be given to participants at the Montvale Clean-up Day.
  - Half are red maples and half are white pines.
  - Very hardy varieties.

### **Old Business:**

- Community Project Update (Lisa De Pellegrini)
  - Update on Bat Education Project (Lisa De Pellegrini)
    - Working on obtaining wood to use for the construction of the bat houses.
    - We will provide fully assembled houses to those who requested them.
- Pascack Trail/Huff Pond Update (Robert Hanrahan)
  - The trail is open and residents are using it.
- Montvale Plastic Bag Recycling Update (Randy Preston/Mairedad Jensen)
  - We have collected a total of 404,446 bags and kept them out of landfills.
  - R. Hanrahan ordered the 4<sup>th</sup> Trex bench. We are going to install them around the bocce courts at Huff Park.
  - R. Hanrahan: There are a few participants from the senior center who will help to install them.
  - Thank you to Trex and Stop and Shop.
  - Thank you to Mairead and Randy as well as Vicki and Ellen.
- Plastic Bag Legislation (Robert Hanrahan) – no news to report
- Electric Vehicle Update (Lisa Skoglund/Antonio Vozzolo) no news to report
- Community Garden Update (Robert Hanrahan)
  - R. Hanrahan: We could provide guidance to the community on how to compost.
  - L. De Pellegrini: We have a pollinator perineal garden that girl scouts built and will maintain.
  - L. De Pellegrini: We could sponsor a speaker to come and present to the community from the botanical gardens.
- Open Spaces and Recreation Plan (Mairedad Jensen/Robert Hanrahan)
  - Barbara Davies from the Land Conservancy of New Jersey will attend the monthly meeting in April.
  - We will meet with her prior to the meeting to tour Montvale's parks and recreational resources.
- Bicycle and Walking Plan (Antonio Vozzolo)
  - Montvale is fairly established in terms of roadways.
  - Municipalities can create bike lanes through repaving and restriping roads.
  - New Jersey has a complete street design guide. It lays out all requirements to establish bike lanes. Bike lanes can be established when the roads are resurfaced or restriped.
  - A technician from DOT can come in and help to find solutions to the lack of space.
  - DOT can come and analyze our resources.
  - Funding can be applied for through state and/or federal grants.
  - A. Vozzolo recommends establishing bike lanes near trains and school facilities.

- R. Hanrahan: This will be included in the Open Space and Recreation plan. It is a long term plan. E-bikes are increasing in popularity.
- R. Hanrahan: NJ has a new law that says that you must provide 4 feet clearance between a bicycle and vehicle when passing a bicycle. If you cannot provide 4 feet of clearance you must slow down to 25 mph.
- R. Preston: The DOT technician could use CAD layouts, they could provide the guidance electronically.

**Council Liaison Report – Chris Roche**

- No new information to report.

**Planning Board Report – Bob Zitelli**

- Use permits are being submitted and approved. Quite a few new businesses are coming to town and filling up office space.
- The former Western Union building located at 100 Summit Avenue will be renovated and will support rehabilitation/residential needs as follows: 60 long term, 60 transitory, and 60 memory care. Once side of the building will be demolished and redeveloped.
