# **Open Public Meeting Statement:**

Adequate notice of this meeting was provided to the Bergen Record and/or The Ridgewood News, informing the public of the time and place according to the provision of the Open Public Meeting Law (Chapter 231, P.L. 1976)

#### **Roll Call:**

**Approval of Minutes** – July 18, 2022 - A motion to approve was made by R. Preston and seconded by L. De Pellegrini.

**Meeting Opened to Public Agenda & Non – Agenda Items -** A motion to open was made by L. Skoglund and seconded by R. Preston.

**Meeting Closed to Public -** A motion to close was made by L. Skoglund and seconded by L. DePellegrini.

### **New Business:**

- Tree Removal Permit Request 25 Hickory Hill, Block 1803, Lot 7
  - o Request started with planning/building department back in April. Homeowner is putting in a new circular driveway.
  - o 3 Maples, 3 Cherry, 2 Ash One Tulip Poplar and one Black Oak is being removed.
  - O Some of the trees are rotted and pose a threat.
  - o Tree to be replaced with 14 Norway Spruces and 25 Green Giant Arborvitae.
  - o Norway Spruces are being scattered around as an ornamental shade tree.

### **Feedback from EC Members:**

• Homeowner is removing shade trees and are replacing them with arborvitae, not shade trees.

- o Tree ordinance requires a 1 to 1 replacement without specification to species.
- We can recommend for replacement varieties such as Red Maples and Linden trees.

Approval of tree removal request for 25 Hickory Hill, Block 1803, Lot 7: A roll call vote was made and approved the request as follows: Lisa De Pellegrini(yes), Chairman Robert Hanrahan(yes), Mairead Jensen(yes), Randall Preston(yes), Lisa Skoglund(yes), Antonio Vozzolo (yes) Michelle Zink-Jojic(yes), Planning Board Liaison/Member Robert Zitelli(yes) & Council Liaison Christopher Roche(abstain)

- Tree Removal Permit Request 13 Main Street
  - o Contract purchaser in attendance. He is a builder working for many years in Montvale and surrounding towns.
  - o Property is a single home on two lots. Subject to a 2 lot subdivision. 125- x 120 deep.
  - o Footprints of houses are similar.
  - o 2 x 3 boulders with 6 foot arborvitaes proposed in between homes for screening.
  - O Shade trees (mixed varieties), not currently identified will be planted for variation in color.
  - Hedges to be planted to the right of the front door. The left sides of the front of the homes will be more elaborate.
  - Trees on street will 2.5 inch caliper and others will be 2 inch caliper. Varieties will depend on time of year planted and stock available.
  - One large Oak tree is being removed and some smaller Maples and Pines will be removed.
  - o Perimeter landscaping will remain.
  - o All trees to be removed are currently flagged.
  - o Replanting anticipated for next spring.
  - o EC members suggestions for shade trees Linden and Maples; specifically Red Maples.
  - o R. Hanrahan: Request that owner will update the map to be specific with species and present to the EC.

Approval of tree removal request for 13 Main Street: A roll call vote was made and approved the request as follows: Lisa De Pellegrini(yes), Chairman Robert Hanrahan(yes), Mairead Jensen(yes), Randall Preston(yes), Lisa Skoglund(yes), Antonio Vozzolo (yes) Michelle Zink-Jojic(yes), Planning Board Liaison/Member Robert Zitelli(yes) & Council Liaison Christopher Roche(abstain)

- Category One, Riparian Zone and Wetland Protection Ordinance Discussion
  - o Tomorrow night R. Hanrahan will be speaking to Planning Board about the subject of riparian zones and waterways.
  - Here in Montvale we have 7 category one waterways. Over 20% of Montvale is DEP Regulated land.
  - o Any tributary off of a category one waterway is considered a category one waterway.
  - o These waterways and tributaries have been determined to be of high value, supporting drinking water and fish.
  - o There are multiple DEP regulations in place concerning waterways in Montvale.
  - The significant impervious surfaces in place around these waterways has contributed to water and wildlife degradation.
  - o 300 feet away from the bank of the C1 waterway is the riparian zone.

- Violations of DEP regulations is contributing to the loss of water quality and increased flooding.
- o Many residents and contractors are not aware of DEP regulations.
- The Mayor suggested we look into writing an ordinance. R. Hanrahan sent out a draft ordinance.

#### **Feedback from the EC Members:**

- o Suggestion to notify residents once the ordinance has been approved.
- o Suggestion to notify homeowner of a category 1 designation in relation to their property.
- o Consider grandfathering properties where construction has already been built.
- o Consider allowances for things such as decks.
- o R. Hanrahan suggests an ERI(Environmental Resource Inventory)
- Every block and lot would have an indicatory saying it has C1 riparian wetland property, or neither. Realtor would be able to look and see a designation on the property.
- R. Hanrahan suggests EC members review the draft ordinance and provide feedback at next meeting.
- Bat Education Program Proposed date of September 18, 2022 from 6:30 to 9:00 p.m.
  - o Cost is \$ 375.00 to bring Joe D'Angeli a licensed Chiropterologist bat expert with helpers.
  - o L. De Pellegrini states that he comes and brings bats, flying foxes, will bring t-shirts and bat houses to sell.
  - The program starts inside with a presentation and then moves outside for a short walk with an echo locator. We find bats outside and then come back in and feed the bats he has brought for his presentation.
  - o R. Hanrahan We will need help from at least 4 EC members. Please let Ellen know if you can help with the program beginning around 6 p.m.

## **Old Business:**

- Community Project Update (Lisa De Pellegrini)
  - O Update on Bat Education Project (Lisa De Pellegrini)
    - Still collecting wood.
    - The boy scouts will assemble the bat houses in September.
    - We will distribute them to residents in the spring.
    - R. Preston suggested asphalt shingles on roof.
- Pascack Trail/Huff Pond Update (Robert Hanrahan)
  - The damaged bench on the trail is on backorder and will be delivered sometime in September.
  - We are waiting for ANJEC to give us recommendations on contractors to help with the erosion problem. We need experts in to get a short term fix in place.
  - o Long term solution will be in concert with Recreation Center.
- Montvale Plastic Bag Recycling Update (Randy Preston/Mairead Jensen)
  - o M. Jensen and R. Preston have done a great job transporting plastic bags to Stop and Shop.
  - o Volume is waning.
- Electric Vehicle Update (Lisa Skoglund/Antonio Vozzolo)
  - o Waiting for borough inventory of vehicles.
- Community Garden Update (Robert Hanrahan) on hold

- Open Spaces and Recreation Plan (Mairead Jensen/Robert Hanrahan)
  - o Plan is still being developed.
  - o B. Davis of the NJ Land Conservancy presented progress to the Mayor and Council.
  - o Will also be presented to the Planning Board.
- Bicycle and Walking Plan (Antonio Vozzolo)
  - o We have not been contacted by the DOT.
  - Suggest that the Mayor contact Josh Gottheimer to try to gain movement on the initiative.
- Tree City Signage (Robert Hanrahan/R. Preston)
  - o Will take some pictures of potential locations and present to the EC members for input.
- Communication about Tree Ordinance to New Families/ New Resident Welcome Mailer (Robert Hanrahan)
  - o Currently, nothing is being mailed out by the borough.
  - o The Mayor stated that a community mailing to new residents will be reinstated.
- Repair of Environmental Learning Center, trail discussion (Robert Hanrahan)
  - o There are some rotted 2 x 6 wood planks on the trail.
  - There are boy scouts who need environmental conservation hours and will replace the planks.

# Council Liaison Report - Chris Roche

- O Discussion about the borough purchasing 28 acres of property on Summit Avenue for \$4,500,000.00.
- o 11 acres are wetlands and 17 acres are buildable.
- o Possible location for a community center.
- o Last week met with local groups on community center discussion.
  - All of the groups (scouts, seniors, etc.) requested 10x10 storage units.
  - Please forward any community resident ideas to C. Roche.

# Planning Board Report – Bob Zitelli

- o North Market/Wegmans location: The planning board approved the Valley Medical Building, as a mixed use location (retail). Of note is potential issues with traffic.
- o Former Western Union building location: Will be redeveloped. Left side will be demolished and replaced with a rehabilitation center. Right side of building structure will remain.
