Communication/Correspondence:

New Business:

- Al Telsey, Special Counsel on Natural Resource Damage (Environmental Attorney)
 - Presents on how to recover money that is due to Montvale but has been placed under the supervision of the DEP.
 - Settlement of 13 million dollars due to Montvale from Environmental Damage done in past years.
 - Suggests that Montvale can recover some of these monies awarded to be used toward NRD projects.
 - It has already been ascertained that Montvale has sustained some type of damage. We need projects to retrieve money.
 - A. Telsey suggests the EC work together to create a list of projects that will fall within the realm of Natural Resource Damage pertaining to this court decision.
 - A. Telsey suggests projects related to waterway, infrastructure, water lines to communities that don't have them, waste water treatment upgrade, stream restoration, dredging and flood control. Projects that return ecological uplift.

- We could also consider projects that cooperate with other municipalities.
- Suggests compelling compliance from the DEP with settlement agreements.
- Suggestions from EC members include: Land acquisition for recreational and/or conservational use.
- Ground Zero: 20 Craig Road.
- Day in the Park – September 9th (discussion of new handout)
 - L. DePellegrini and L. Skoglund will attend. M. Jensen and L. Baldanza will also help.
 - We have a tent and a Tree City banner.
 - E. Riccardi will place order for table and chairs.
 - M. Zink-Jojic suggests a handout with a recipe for a homemade natural bug repellent. We could have some of the repellent available at the table for residents to try and a QR code with the recipe available.
 - Fireworks start at 8:30 p.m.
- Montvale Grove
 - Some EC members were not able to access the submitted documents on the google drive.
 - L. Skoglund states that the most recent plans are required to review the landscape plan.
 - L. Skoglund states that we need to review the trees scheduled for removal. A discussion with a Montvale Grove representative and the EC committee may be necessary.
 - Montvale has a storm water ordinance that must be adhered to. There must be 35% open space provided on that plan and it must be documented.
 - L. DePellegrini stated that the location is a vernal habitat which falls under the jurisdiction of the Fresh Water Wetlands Protection Act.
 - L. Skoglund requests that the EC review an accurate listing of the plantings prior to the next meeting.
 - L. Skoglund states that we are invited to walk the property but need to be cautious and do so in small groups (2-3 members) so as to avoid a quorum.

 - L. DePellegrini suggest we present education series of presentations to the community.
 - The Raptor Trust presents on how to keep our raptor's safe. Many raptors are killed b/c they eat rodents that have been poisoned.
 - L. DePellegrini will find out more information.
