### **Communication/Correspondence**

- Review the Value of Trees document; the document will be formatted into a tri-fold, reviewed by the EC ,submitted to M&C for their review and once approved be distributed thru the building department.
- Title will be changed to "Tree Value in Montvale".
- Mission statement will be omitted.
- L. Skoglund submitted information regarding wind effects on trees and said it should be under consideration to become part of the document.
- Climate section needs condensing.
- The brochure would be available on the borough social media accounts, in the building department and provided when a contractor or homeowner is either applying for demo permit or looking to remove an excessive amount of trees.
- Brochure is intended to educate and possibly prevent an excessive removal of trees.

#### **Environmental Commission Activity List**

- Interest in instituting a mass transit tram to shuttle riders from the center of town (train station) to the local corporations was discussed.
- Modifying the current train schedule, thus resulting in the train arriving earlier in Montvale, and increase riders.
- Pascack Valley Passing Sidings Environmental Assessment was explained by PB Chairman De Pinto. The document will be emailed to the commission for their review.

#### **Old Business**

- Pending tree ordinance continues to be discussed and modified. Chairman Hanrahan will present a draft at M & C meeting.
- Chairman Hanrahan and commission prefers the term indiscriminatory tree removal to the term clear cutting.
- The EC believes two separate ordinances are required. Goal of these two ordinances is remove excessive amounts of trees through a simply written ordinance permit.
- First ordinance will be applied in cases when the building department issues a demo second ordinance applies in cases when a renovation permit is issued.
- If trees are removed in the setback area or in buffer zone, the homeowner or developer would be required to appear before the EC.
- Emerald Ash Borer continues to be discussed. Chairman Hanrahan provided photos and information regarding the Emerald Ash Borer. Borough of Hillsdale has confirmed cases of the Emerald Ash Borer. The secretary has contacted Hillsdale EC secretary and will give a report next month.
