### **New Business**

- Landscaping suggestions for Pee-Wee Field (located next to United Way project).
- No budget has been set. Parking for use of the field & access for pedestrians was discussed.
- Creating a focal point of interest; sculpture, water feature, or peaceful area were suggested. Not favorable location for dog park.
- Due to close proximity to residential homes, EC believes there should be limited hours and access to park area. Replacement of the fence around the perimeter was also recommended.
- Multi uses for the land, which was formerly the swim club. Suggestions were open recreational field, walking path and other ideas. Dog park was dismissed due to extra traffic and close proximity to ball fields, residential neighborhood, and the playground.
- New "Welcome to Montvale" signs for center of town was discussed. Possible Boys Scouts project.
- Install additional pavers and bench at Veterans Memorial Park, in center of town. Possible Boys Scouts project.
- Promoting local corporations sustainability products on website. Secretary will check with web site Council Liaison Curry and report back.
- Welcomed new member Melinda Kelly to the EC. M. Kelly provided the EC with her background information.
