Approval of Minutes – June 21, 2021- A motion to approve was made by R. Zitelli and second by D. Eichhorn.

Meeting Opened to Public Agenda & Non – Agenda Items – no public present

New Business:

- Tree Removal Request Block 1301, Lot 20, Zone R-40 (20 Donnybrook Road)
 - o Application as originally submitted was not compliant with borough code because if was missing compensatory tree planting.
 - Chairman Hanrahan reached out to resident to explain the ordinance and asked applicant to modify the application.
 - o Residents were happy to comply once they understood the ordinance.
 - The home is scheduled to be demolished. The tree removal application must be reviewed based upon the current circumstances.
 - o Agreement to wait until after construction for compliance.
 - o Recommendations from the EC: Blue Spruces, Douglas Fir, White Pines (deer resistant).

Approval of tree removal request submitted by property owner for Block 1301, Lot 20, Zone R-40 (20 Donnybrook Road) A roll call vote was made and approved the request as follows: Lisa De Pellegrini(yes), Daniel Eichhorn(yes), Chairman Robert Hanrahan(yes), Mairead Jensen (absent)

Randall Preston(yes), Lisa Skoglund(yes), Vicki Solis (absent), Michelle Zink-Jojic(yes) Planning Board Liaison/Member Robert Zitelli(yes) & Council Liaison Christopher Roche(abstain)

- Borough Tree Removal Policy
 - o Policy is the code. R. Hanrahan met with the Building Department to review the code and ensure all expectations/questions of residents are answered and communication between departments is efficient.
 - o Consensus was that we are not seeing clearcutting at present and the tree ordinance has helped.

Comments from the EC members on publicizing the ordinance:

- Language was added to the tree brochure stating that Montvale has a tree ordinance.
- Searchable information on the borough website.
- Communicate with/educate local tree contractors.
- Install a sign or plaque in town.
- Add information to bulletin display at Memorial Park.
- Display a sign at our tent on Day in the Park informing residents that Montyale has a tree ordinance.

Open Spaces

- Shannon is working on open space inventory past/current history.
- o R. Hanrahan shared a tree inventory that is approximately 8 to 9 years old which is a good starting point/can be updated.
- o Some grants require a tree inventory.
- We can start a database using the tree removal application information.

Fundraising

- O Discussion includes fundraising for trail, land acquisition, and crossing light to connect to other municipal trails.
- We require committee members to take the lead. R. Hanrahan ask EC committee for any members interested in working on fundraising.

Old Business:

- Community Project Update (Lisa De Pellegrini)
 - Day in the Park Bat Education with Chris Volk.
 - o Boy Scouts might help the EC with build and distribute of bat houses
 - o EC member suggestions:
 - An event to show off finished projects/bat houses.
 - Families/children sign up at Day in the Park to get a bat house kit. Boy Scouts could do the prep work and prepare kits before distribution.
 - Distribute plans for families to construct bat houses at home.
 - Mass produce kits to be distributed at Day in the Park. Hold a contest and announce a winner the week of Halloween; create enthusiasm for the project.
- Pascack Trail Update (Robert Hanrahan)
 - o Boy Scouts will install 3 benches on the trail and replace fence.
 - o Trail was marked by Vicki and Joe Solis and Ellen Riccardi.
 - o Trail signs are installed.

- Shannon and Bob initiated a discussion with the fire chief regarding a traffic light on Grand Ave to allow road crossing and be used for Fire and Police activity. To be discussed with John DePinto (Planning and Zoning).
- Huff Pond Update (Robert Hanrahan)
 - o The water is flowing in and out/check valve is working. The pond has water.
 - Soil has been removed
 - o Fence will come down soon.
 - o Planting of new trees will begin end of September.
 - o Fish will be stocked in September.
- Montvale Plastic Bag Recycling Update (Randy Preston/Mairead Jensen)
 - o The program will continue until the end of the year
 - o M. Jensen/V. Solis/R. Preston have been transporting bags to Stop and Shop.
 - Plastic Bag Legislation November begins state roll out starting with business before residential regulation.
 - o EC will distribute a flyer for roll out.
 - o Beginning in May 2022 Styrofoam containers and plastic bags will not be allowed.
 - o The EC will update the Facebook page with information as it becomes available.
 - o Shopping bag give away at Day in the Park on August 28th
