Chairman De Pinto stated that the applicant has aloted 2.2 million dollars for road improvements that must be completed before the opening of Wegman's. Said resident also stated he believes the laws regarding affordable housing would be changing and Monvale would not be required to build additional units. Board members stated they believed the same, thirty years ago. The resident thanked the board for their time and found the meeting very interesting.
